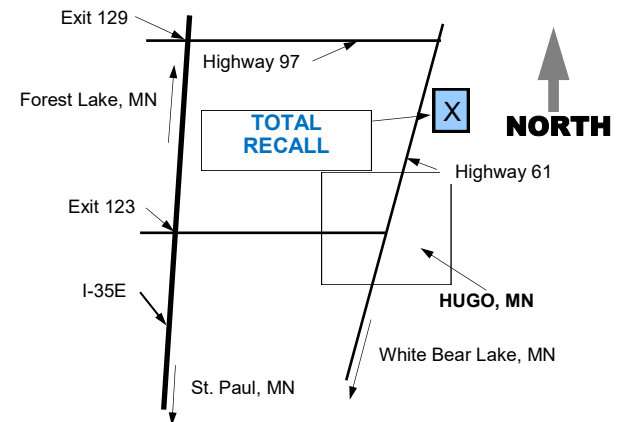
## Routes To Show Site

**FROM SOUTH (St. Paul, MN)** ... I-35E North to exit 123 (Centerville/Hugo Exit), East (right) 1.8 miles to Hwy 61, North (left) 2.8 miles.

**FROM WEST (Minneapolis, MN)** ... I-35W North to I-35 North to exit 129, Hwy 97, East (right) 2 miles to Hwy 61, South (right) 3.7 miles.

**FROM NORTH** ... I-35 South to exit 129, Hwy 97, East (left) 2 miles to Hwy 61, South (right) 3.7 miles.

**FROM EAST or WEST** ... the showsite is located North of I-694, to I-35E North to exit 123 (Centerville/Hugo Exit), East (right) 1.8 miles to Hwy 61, North (left) 2.8 miles.



## Site & Ring Procedures for COVID-19 Compliance.

**General procedures for both Obedience and Rally.** Handlers will check themselves in and pull their armbands and rubber bands. Judges will not hand out placement ribbons, you'll have to pick up your own, much like agility.

### Obedience:

**Novice**—No posts for figure 8, big cones instead. Leash can be placed in a tote held by steward who will put it on the "go get it" chair. Stays will be the same as regulation. Judge will sanitize between dogs, (this is due to the requirement that the judge touch the dog on the stand/stay exc.)

**Open**—Figure 8 the same as Novice. Handler will leave their Dumbbell on a chair just outside the ring and recover it themselves. Stewards changing jumps will be assigned to a jump for the entire class and will sanitize before and after each class. Handler will deposit their leash on the "go get it chair" and later will go get it. Steward will then wipe each leash chair. Handler will pick up DB on the way out of the ring.

**Utility**—For articles, we will use a plastic container. Handler will place articles in the tub with gloves on top prior to entering the ring. Glove steward will use tongs or rubber gloves to handle gloves, (there will be a lot of tong use in this class). If gloves are used by Steward, Steward will sanitize between exhibitors. Article Steward will select the in use articles and place them on the in ring chair using tongs. When the article ex comes up, article Steward will place the pile using tongs. Judge will take the article on the clipboard, as usual and place in the pile. After the ex is completed, article Steward will recover the articles with tongs or gloves. Judge will sanitize between dogs for the moving stand exc. As with Open, Stewards will be assigned jumps to change

### Rally:

Walk throughs will be limited in both number and time. Details to be determined by entry. Exhibitors, please practice doing walk throughs so you can cut the number of times you need to walk a course before you feel comfortable working it. Leash runner in Masters and Advanced will wear gloves.

If you are showing in only one class, please crate in your car.

Crating will be very limited and reserved for handlers who are showing in more than one class (UDX or Rally Triple Q) or more than one dog. **Crates for these multiple entries may be left overnight.**

**Do not arrive more than an hour prior to your schedule run.** Leave immediately after your class is awarded or sooner. Masks must be worn in the building. This includes the exhibition Ring. No children under 13 unless showing and no spectators are invited to these trials. **Thank you.**
