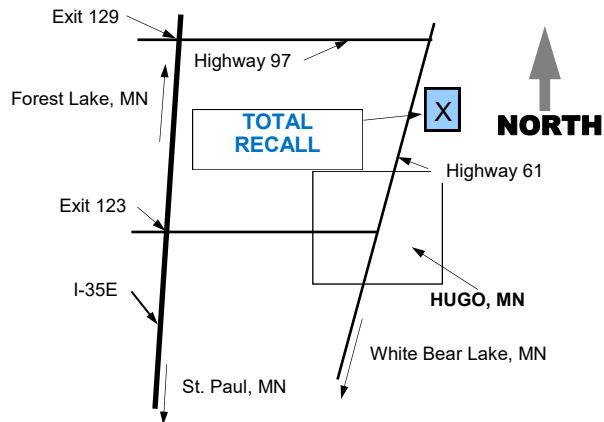
## Routes To Show Site
