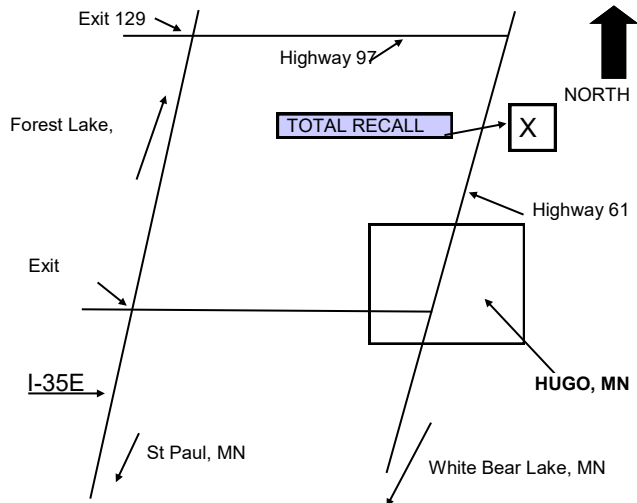

EXHIBITORS . . . PLEASE NOTE

Post Dated, Returned Checks or Declined Credit Cards do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check or declined credit or debit card.

Entries not on an official AKC Entry Form and photocopies of Entry Forms without the Agreement and Rules on the reverse side of the AKC Official Entry Form are not acceptable. **Entries received without fees** will not be accepted.

Mail all entries with fees to Event Secretary, Cindy O'Hare, 8221 Griffith Ave NW, Maple Lake, MN 55358. Acknowledgment of entries will be made as soon as practicable with entry identification cards. The person accompanying the dog to the show must show this identification before the dog will be received. Should such acknowledgment not be received by the exhibitor within a reasonable time, please notify the Show Secretary at 320-963-7705.

Make checks/money orders payable to Cindy O'Hare, Event Secretary. Please mail checks/money orders with entries. The Secretary assumes no responsibility for cash sent through the mail. **Canadian Exhibitors** make fees payable in U.S. Funds.

No entry shall be made and no entry shall be accepted which specifies conditions as to its acceptance.

Entry fees shall not be refunded in the event the dog is absent, excused, disqualified by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to complete the show, no refund of entry will be made.

Errors on entry blanks. Owners are responsible for errors in making out entry forms, whomever shall make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the closing date.

No refund of duplicate entries.

Consult judging program for time of judging.

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS as set forth on the Official AKC Entry Form for these events.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not needed for further judging will be excused.

Judges will not wait for any dog holding up a class. Owners/agents are responsible for having their dogs in the judging rings when classes are called. The Show-giving Club and the Secretary have no obligation or responsibility for providing services through a public address system or stewards or runners for the purpose of calling/locating dogs.

All dogs present must be on leash or confined to their crates unless they are being judged or in the exercise ring.

Bitches in season (on the date of the show) are not permitted to compete . . . American Kennel Club *Obedience Regulation*, amended to November 11, 2013. Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the club giving the show will return the entry fee less \$10.00 per entry to the owner of the bitch, with Veterinarian's Note.

Rules and regulations of civil authorities and/or building or location restrictions will apply to all persons on the trial premises. This is a **SMOKE-FREE BUILDING**.

Outside exercise area is provided . . . Failure to pick up after your dog may result in being asked to leave the trial with no refund of entry fees.
