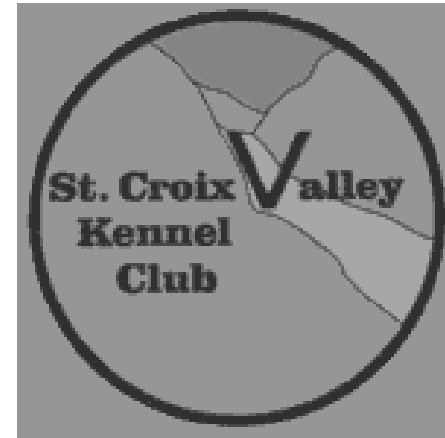

ROUTES TO ST CROIX VALLEY KENNEL CLUB, INC SHOW

Directions to Animal Inn Show Center

FROM THE NORTH: I-35 to I-35E at the split. I-694 East and South to County 14(Old Highway 5.)
Take County 14 East to Animal Inn on the right.

FROM THE SOUTH: I-35 to I-35E at the split. I-494 East and North to County 14 (Old Highway 5)
East to Animal Inn on the right. OR Highway 10 and 61 to I-494, then follow previous directions.

FROM THE EAST: I-94 TO I-694, I-694 North to County 14 (Old Highway 5) and follow previous directions.

FROM THE WEST: Same as from the East.

NOTICE TO EXHIBITORS

UNSIGNIED ENTRIES CANNOT BE ACCEPTED. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Entries received without fees will not be accepted. Acknowledgment of entries will be made as soon as practicable with entry identification cards and judging program. Should such acknowledgment not be received by the exhibitor within a reasonable time, please notify the Show Secretary's Office.

MAKE ALL CHECKS AND MONEY ORDERS PAYABLE TO . Cindy O'Hare, DSBD

CANADIAN EXHIBITORS must make fees payable in **U.S. FUNDS**. Please mail checks or money orders with entries. Secretary assumes no responsibility for cash sent through the mail. Tabulate carefully.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

POST DATED CHECKS, RETURNED CHECKS, AND DECLINED CREDIT CARDS do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check or credit card declined. Subsequent returned checks or declined credit cards from the same exhibitors may result in their being put on a CASH ONLY basis,

NO REFUND FOR DUPLICATE ENTRIES. Every effort to find all duplicate entries will be made; however, if the entry has been processed, no refund will be made.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES except when being judged.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that Show is over, and the Secretary advised at once. The Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

ALL PRIZES must be claimed at the show . . . If not, they become the property of the Show Giving Club.

NO PRIZES will be mailed.
