From the South:

I-35 to Midway Road; Midway Road to Hwy I-94
Cross Hwy 53 to Lindahl Road (look for Casa Latte
Restaurant); continue on Lindahl Road 2 miles.
Building is on the right.

From the Iron Range:

Hwy 53 south to past Pike Lake to Lindahl Road
(Casa Latte Restaurant will be on the left); turn left
on Lindahl Road; continue 2 miles to building on the right,

From Superior, WI:

Take the Blatnik Bridge ("High Bridge"); keep in the
left lane and take the exit to I-35 South; take
immediate exit marked 21st Avenue West. Continue
up the hill toward Hwy 53. At the third set of traffic
lights, turn left on Hwy 53. Continue on Hwy 53 to
Lindahl Road (about 10 miles); turn right on
Lindahl Road (Casa Latte Restaurant is on the right,
on the corner); continue on Lindahl Road 2 miles.

EXHIBITORS . . . PLEASE NOTE

Closing Date for entries . . . 12 NOON, Wednesday, June 28, 2017, after which time entries cannot be accepted, canceled or substituted except as provided in Chapter 11, Section 6 of the *AKC Rules Applying to Dog Shows*.

Post Dated, Returned Checks or Declined Credit Cards do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check or declined credit card or debit card.

Telegraph, telephone, or unsigned entries cannot be accepted.

Entries not on an official AKC Entry Form and photocopies of Entry Forms without the Agreement and Rules on the reverse side of the AKC Official Entry Form are not acceptable. Entries received without fees will not be accepted.

No entry shall be made and no entry shall be accepted which specifies conditions as to its acceptance.

Entry fees shall not be refunded in the event the dog is absent, excused, disqualified by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to complete the show, no refund of entry will be made.

Errors on entry blanks. Owners are responsible for errors in making out entry forms, whomever shall make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the closing date.

No refund of duplicate entries.

The Twin Ports Dog Training Club, does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.

Management is NOT responsible for the loss of, damage to, or death of any dog exhibited, or for the possessions of any participant, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.

Consult judging program for time of judging.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not needed for further judging will be excused.

Judges will not wait for any dog holding up a class. Owners/agents are responsible for having their dogs in the judging rings when classes are called. The Show-giving Club and the Secretary have no obligation or responsibility for providing services through a public address system or stewards or runners for the purpose of calling/locating dogs.

All dogs present must be on leash or confined to their crates unless they are being judged or in the exercise ring.

Bitches in season (on the date of the show) are not permitted to compete . . . American Kennel Club *Obedience Regulation*, amended to January 1, 2005.

REFUND OF ENTRY FEES less \$10.00 will be given to the entrants of bitches in these obedience and rally trials, upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial, if received one half hour before start of all judging on the trial date.

Rules and regulations of civil authorities and/or building or location restrictions will apply to all persons on the trial premises. This is a SMOKE-FREE BUILDING.

Outside exercise area is provided . . . please use Designated area.... All other areas are off-limits Failure to pick up after your dog may result in being asked to leave the trial with no refund of entry fees.
