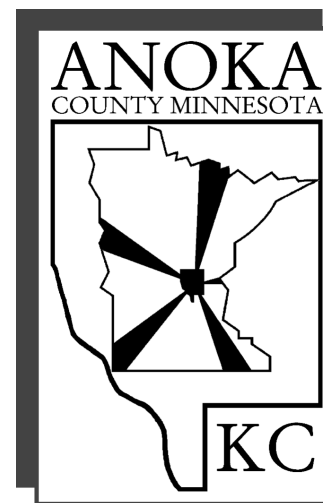


Effective January 1, 2010: Chapter 11, Section 1.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES except when being judged.

ALL TROPHIES must be claimed at the show . . . If not, they become the property of the Show Giving Club.

NO TROPHIES will be mailed.

ANOCA COUNTY MINNESOTA KENNEL CLUB, RESERVES THE RIGHT to substitute trophies with ones of equal or greater value.

BITCHES IN SEASON (on the date of the show) are not permitted to compete . . . American Kennel Club *Obedience Regulation*, amended to November 11, 2013. Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the club giving the show will return the entry fee less \$10.00 per entry to the owner of the bitch.

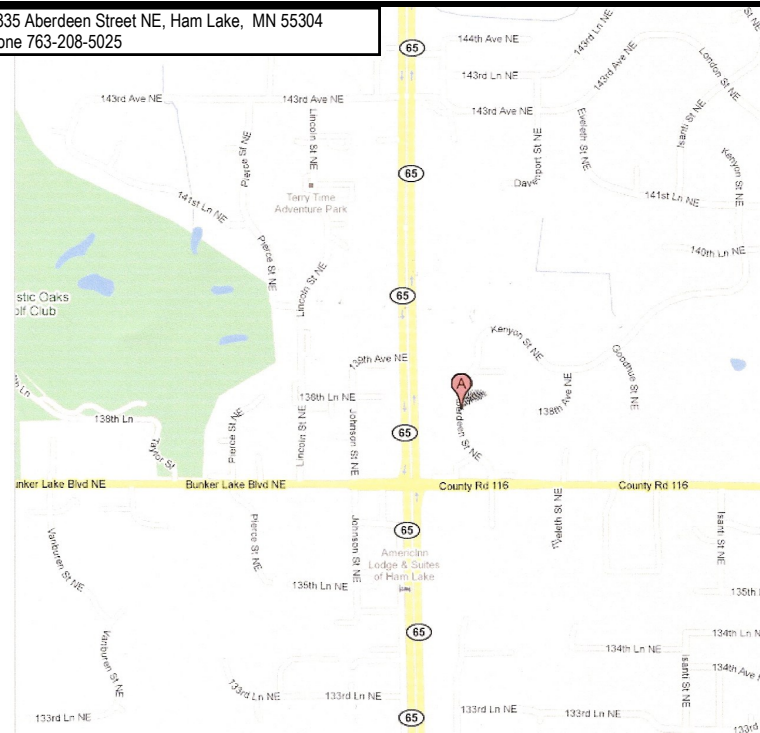
Notice:
