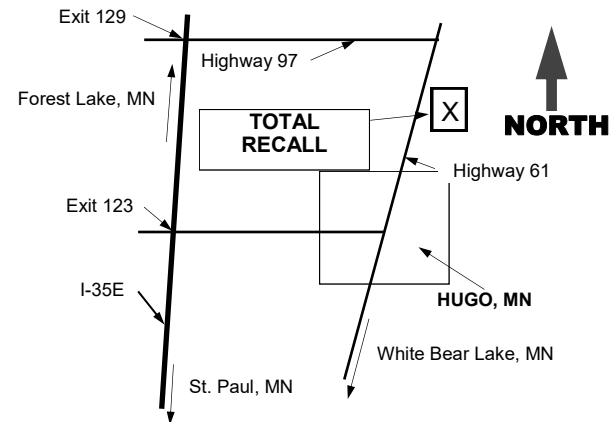
Routes To Show Site
