

ROUTES TO THE SHOW SITE



FROM THE NORTH: Take I-35W to Stinson Blvd. exit. Turn South on Stinson and continue to Broadway, go right (West) on Broadway about 1 1/2 blocks to the first driveway on right, after the "BREDE" sign. Entrance is in back of building at lower level.

FROM THE SOUTH or WEST: Take I-35W North. to the New Brighton Blvd/Highway 88 exit. Turn right on New Brighton Blvd. Turn left after 1 block on Broadway St. Drive 2-1/2 blocks to the driveway immediately after 2101 Broadway.

FROM THE EAST: Take I-94 to Hwy. 280. Go North to the Hennepin/Larpenteur Exit & turn left. Turn right on Industrial Blvd. Turn left on Broadway. Proceed about 1 1/2 miles to 2101 Broadway.

EXHIBITORS . . . PLEASE NOTE

Entry fees shall not be refunded in the event the dog is absent, excused, disqualified by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to complete the show, no refund of entry will be made.

Errors on entry blanks. Owners are responsible for errors in making out entry forms, whomever shall make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the closing date.

No refund of duplicate entries.

Consult judging program for time of judging.

Only dogs that are eligible to be shown under The American Kennel Club rules shall be allowed within the show precincts . . . American Kennel Club *Rules Applying to Dog Shows*, Chapter 11, Section 11.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not needed for further judging will be excused.

Judges will not wait for any dog holding up a class. Owners/agents are responsible for having their dogs in the judging rings when classes are called. The Show-giving Club and the Secretary have no obligation or responsibility for providing services through a public address system or stewards or runners for the purpose of calling/locating dogs.

All dogs present must be on leash or confined to their crates unless they are being judged or in the exercise ring.

Bitches in season (on the date of the show) are not permitted to compete . . . American Kennel Club *Obedience Regulation*, amended to November 11, 2013. Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the club giving the show will return the entry fee less \$10.00 per entry to the owner of the bitch.

REFUND OF ENTRY FEES minus \$10.00 per event, will be given to the entrants of bitches in these obedience and rally trials, upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial, if received one half hour before start of all judging on the trial date.

Rules and regulations of civil authorities and/or building or location restrictions will apply to all persons on the trial premises. This is a **SMOKE-FREE BUILDING**.

Outside exercise area is provided . . . please use gravel exercise area **and on hill above gravel area**. **ALL OTHER AREAS ARE OFF-LIMITS.**

Parking allowed only in designated areas up above. Two handicapped parking spaces are provided on the lower level, otherwise the lower level is reserved for loading and unloading only. Unattended vehicles parked on lower level will be towed.
