

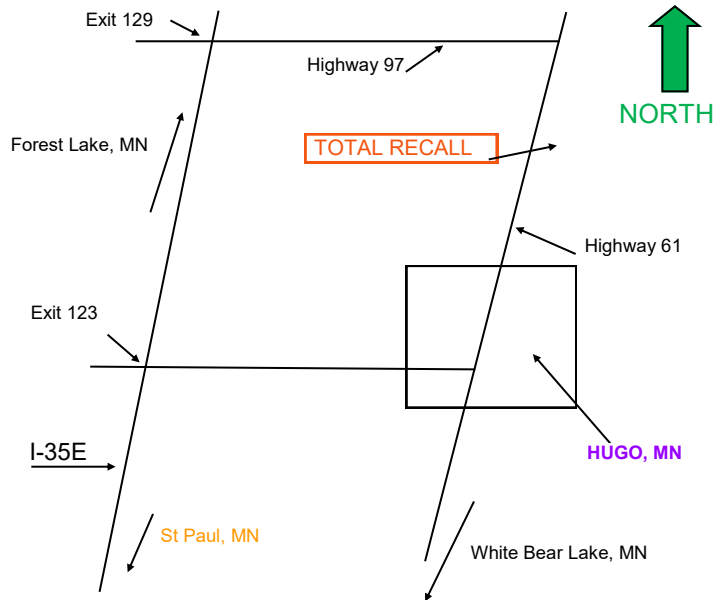
**ROUTES TO SHOW SITE**

**FROM NORTH** ...I-35 South to exit 129, Hwy 97, East (Left) 2 miles to Hwy 61, South (right) 3.7 miles.

responsible for the presence of their dogs in the judging ring when their classes are called to be  
judged.

**ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES** except  
when being judged.

**ALL TROPHIES** must be claimed at the show . . . If not, they become the property of the Show Giving  
Club.

**NO TROPHIES** will be mailed.

**BITCHES IN SEASON** (on the date of the show) are not permitted to compete . . . American Kennel Club *Obedience  
Regulation*, amended to January 1, 2019. Females in season are not permitted to compete. If a female is  
withdrawn from competition because it came into season and the event secretary is notified no later than one  
half hour prior to the start of the first class in the trial, the club giving the show will return the entry fee less  
\$10.00 per entry to the owner of the bitch.
