

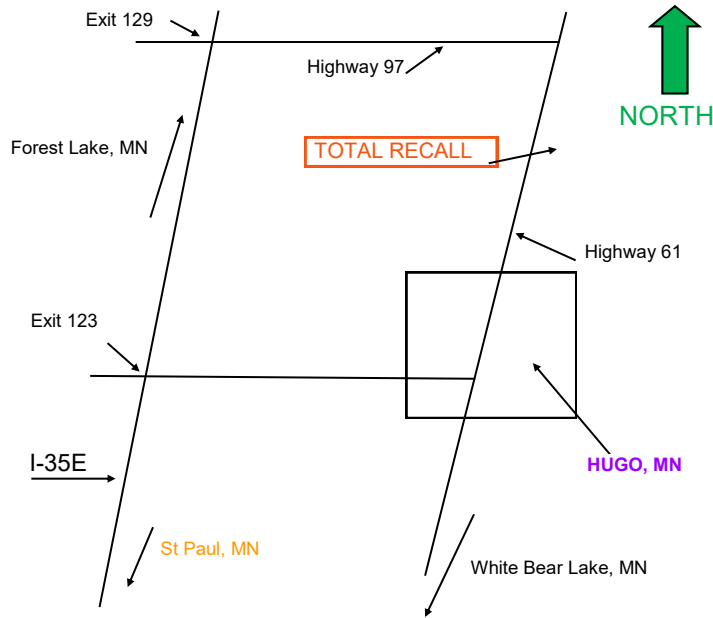
ROUTES TO SHOW SITE

FROM WEST (Minneapolis, MN) I-35W North to I-35 North to exit 129, Hwy 97, East (right) 2 miles to Hwy 61 South (right) 3.7 miles.

FROM NORTH ...I-35 South to exit 129, Hwy 97, East (Left) 2 miles to Hwy 61, South (right) 3.7 miles.

FROM EAST OR WEST...I-694, to I-35E North to exit 123 (Centerville/Hugo Exit), East (right) 1.8 miles to Hwy 61, North (left) 2.8 miles.

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS as set forth on the Official AKC Entry Form for these
events.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms, whoever may make such
errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
